

Letter to Parents and Guardians: Red Zone Designation October 14, 2020

Dear Parent(s)/Guardian(s),

As you may be aware, the provincial government announced on Saturday that the following regions are designated as being in a red zone:

- Gatineau
- MRC des Collines

As a result of this announcement, there are a number of measures that we are required to put into effect. The two documents that follow outline the directives we have been issued. Please take note of the following:

- Students at D'Arcy McGee High School, Philemon Wright High School, and St. Mike's High School will be required to wear face coverings at all times while on school grounds
- Secondary IV and V students at D'Arcy McGee High School, Philemon Wright High School, and St.
 Mike's High School will attend school on a rotating schedule, whereby the are in classes at school
 one day, and attend virtual classes the next; respective schools will provide additional information

It is important to note that all WQSB schools and centres continue to follow all directives and guidelines as issued by the government and Santé Publique; we remain fully committed to ensuring that all necessary safety measures are in place so as to provide the most secure conditions for our students and staff.



School transportation and public transit













- 1 Face coverings are not mandatory for students from Elementary 1 to 4 but may be worn when they are using school transportation or are in common areas.
- 2 The government will provide procedural masks for employees in the school network. Mask supplies will be provided locally by school service centres, school boards and private schools School staff are subject to the applicable rules regarding occupational health and safety. Note that preschool teachers (Kindergarten for 4- and 5-year-olds) do not have to follow social distancing rules with their students. However, they must wear personal protective equipment.
- 3 Physical education and health teachers are not required to wear a face covering if they are teaching in the school's sports facilities and remain 2 m away from their students.
- Face coverings are not required if the 1.5-m distance is respected or if individuals reside in the same household or are accompanied by a person providing services or support.

Rules pertaining to face coverings complement the other health measures in place.

All students required to wear a face covering must provide their own.

EDUCATION SYSTEM

Health measures by regional alert level

Special pedagogical projects, extracurricular activities and optional courses help students stay in school and succeed.

More than ever, it is important for us to keep working together to help stop the spread of the virus and provide young people with conditions to help them thrive.

These guidelines are based on the progressive regional alert and intervention system published by the public health authorities.

This plan is based on three key premises:

- Reducing the risk of outbreaks
- Facilitating epidemiological investigations when COVID-19 cases occur
- Minimizing the number of complete school closures

When a school located in a region within a red zone is closed, distance learning services will be provided, as planned, to students based on the minimum number of required hours and emergency daycare services will be provided to employees who are affected. Additionally, certain professional services could be provided at a distance in order to support student learning. This also applies if a school closes in an orange or yellow zone.





The groups must be the same every week, but it may be possible to change the groups after the December break, as the students will not have been in contact with each other for 14 days.

² Priority must be given to optional courses that are prerequisites for college-level programs; these courses can be offered in person or through distance education.
